High-Level Side Event – SDG Summit and HLM on UHC 2023

The first half the era of the Sustainable Development Goals has not yielded significant progress towards reaching development and health for all and leaving no one behind. One of the biggest obstacles to reaching the SDGs is alcohol. Alcohol harm is a major obstacle to reaching 14 of 17 SDGs and alcohol's contribution to the global burden of disease has been increasing.

Member States of the World Health Organizations have recognized the lack of progress and identified alcohol as public health priority with urgent need to accelerate action. In 2022, Member States unanimously adopted the Global Alcohol Action, with a renewed focus on the most cost-effective, high-impact, and scientifically proven alcohol policy solutions.

Objectives

- This event aims to take stock of key challenges in developing and implementing evidence-based and ambitious alcohol policy solutions. How can those challenges be overcome?
- The event will showcase best practices from countries and provide a platform for discussion, and experience sharing.
- The discussion will chart benefits of cross-border and international collaboration among member states, and the potential of technical support and normative guidance from the World Health Organization.
- The event will outline the role of communities in the implementation of the global alcohol action plan to help ensure ambitious action and achieve progress that benefits all.
